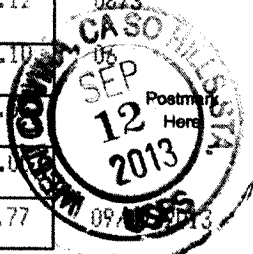

The above-identified opposer, **Glory Y. Tsai** and his business **GLORY HOUSE** have been seriously damaged, not only financially but also to personal reputations, identities and credits, as a result of trademark and trade name infringement and registration (Serial No. 85789420) committed by applicant Jo Ann Goin and her BJK Glory House Catering Co., LLC.(applicant) and hereby opposes the same.



1  
2           **The grounds for opposition are as follow:**

3           1.       An extension of time to oppose was timely filed by Opposer Glory Y. Tsai (Full  
4 name: Glory Yau-Huai Tsai, sole owner of registered trademark GLORY HOUSE,  
5 registration number 1879695) on May 21, 2013, and has been granted (ESTTA Tracking  
6 number ESTTA539159) with respect to this application (Serial Number 85789420). The  
7 extension of time to file opposition was granted to 09/18/2013. (Attached Exhibit – K)

8           2.       Opposer Glory Yau-Huai Tsai, submit the following **NOTICE OF OPPOSITION**  
9 regarding Application Serial Number 85789420 for the mark GLORY HOUSE of applicant Jo Ann  
10 Goin and her associated group (applicant) BJK Glory House Catering Co., LLC.,

11  
12           3       pursuant to T.M.E.P. Section 1207.01- Likelihood of Confusion

13           (--Because of established marketing practices, the use of identical marks on seemingly  
14 unrelated goods and services could result in a likelihood of confusion, See In re Phillips-Van  
15 Heusen Corporation, 228 USPQ page 949, 951 (TTAB 1986))

16           4.       Even though defendants' (applicant's) business services and goods are unrelated to  
17 Opposer (plaintiff) Mr. Glory Yau-Huai Tsai's business services and goods, since defendants'  
18 (applicant's) application mark name is exactly the same as the trademark name GLORY HOUSE  
19 which belongs to plaintiff (Opposer) Glory Y. Tsai (Full name: Glory Yau-Huai Tsai),  
20 nobody can prove and deny that no confusion has occurred.

21           5.       Confusion can occur at any time, anywhere, at any moment about who the owner  
22 of the business name "GLORY HOUSE" is.

23  
24           6       15 U.S. Code Section 1052 (d) (----unless it consists of or comprises a mark which  
25 so resembles a mark registered in the Patent and Trademark Office, or a mark or trade name  
26 previously used in the United States by another and not abandoned, as to be likely, when used on,  
27 to cause confusion, or to cause mistake, or to deceive; --)



1           11       Opposer Glory Y. Tsai (Full name: Glory Yau-Huai Tsai) is the sole owner of trade  
2 mark Registration Number 1879695 for standard name mark GLORY HOUSE and its design. Opposer  
3 Glory Yau-Huai Tsai (Glory Y. Tsai), has been continuously performing business services since 1975  
4 **(See Attached Exhibit – J)** by using the trademark name “GLORY HOUSE” and continues to do so  
5 currently and in the foreseeable future.

6  
7           12       Defendants (applicant) BJK Glory House Catering Co., LLC and the alleged owner Jo  
8 Ann Goin of BJK Glory House Catering Co., LLC (applicant) confess that their business name is  
9 called “**BJK Glory House Catering Co., LLC**” but defendants willfully **refuse to use the words**  
10 **“BJK”, “Catering” or “Catering Co., LLC”** in their service mark.

11           13.       Applicant, BJK Glory House Catering Co., LLC and the alleged owner Jo Ann Goin of  
12 BJK Glory House Catering Co., LLC (applicant) know so clearly that the name/mark “**BJK**” is a  
13 **trademark which belongs to some other company.**

14           Applicant, BJK Glory House Catering Co., LLC and the alleged owner Jo Ann Goin of BJK  
15 Glory House Catering Co., LLC know so clearly that they cannot use another company’s trademark  
16 name “**BJK**” as their (applicant’s) service mark; but the applicant is willfully infringing upon  
17 **Opposer’s Glory Yau-Huai Tsai’s trademark name “GLORY HOUSE”.**

18           **Obviously, applicant has already made their judgment that the person named “Glory**  
19 **Yau-Huai Tsai” or “Glory Y. Tsai” is an Asian person, an Asian lady, or even an old Asian lady**  
20 **or man older than 60 years old. Applicant has already made up their mind that it is impossible**  
21 **for an old Asian lady or man to say something against them.**

22           **Obviously, Applicants,** BJK Glory House Catering Co., LLC and the alleged owner Jo Ann  
23 Goin of BJK Glory House Catering Co., LLC **have the serious state of minds to intentionally**  
24 **commit fraud.**

25           14       Defendants (applicant) BJK Glory House Catering Co., LLC and Jo Ann Goin, owner  
26 of “BJK Glory House catering company, LLC” filed a service mark application for the mark “GLORY  
27 HOUSE”, which was assigned an application serial number of 85789420 in the United States Patent  
28



1 and Trademark Office on November 28, 2012.

2 15. The application filed by Applicant Jo Ann Goin, owner of “BJK Glory House catering  
3 Co. LLC”(applicant), on November 28, 2012 was based on applicant Jo Ann Goin’s alleged use of the  
4 Applicant’s Mark with the Applicant’s Service at least as early as 01/01/2000 (“the Applicant’s  
5 Alleged First Use Date”).

6 16. The Application (Serial Number 85789420) for the Applicant’s Mark (GLORY HOUSE)  
7 was published for opposition in the Official Gazette on May 21, 2013.

8  
9 17. Two months prior to the Applicant’s application (Serial Number 85789420) (GLORY  
10 HOUSE) being published in the Official Gazette, **on March 05, 2013**, the Opposer GLORY YAU-  
11 HUAI TSAI (First name: **GLORY**, Middle initial: **Y.**, Last name: **TSAI**) filed a “Letter of Protest”;  
12 and said “Letter of Protest” was accepted by the COMMISSIONER for TRADEMARKS.

13 18. The Opposer GLORY YAU-HUAI TSAI (First name: **GLORY**, Middle initial: **Y.**,  
14 Last name: **TSAI**) with his good faith to the COMMISSIONER for TRADEMARKS, **believes that the**  
15 **‘Letter of Protest’** which had been accepted by the COMMISSIONER for TRADEMARKS on  
16 **March 05, 2013 is still in effect and can be amended after more evidences are provided.**

17 19. On May 21, 2013, Opposer Mr. Glory Yau-Huai Tsai filed a request to extend time to  
18 oppose, and it **was granted until 09/18/2013** (ESTTA Tracking Number: **ESTTA539159**).(Exhibit-K)

19 20. The Opposer Glory Y. Tsai (Full name: Glory Yau-Huai Tsai) is the sole owner of U.S.  
20 Registration Number **1879695** for the mark “GLORY HOUSE” filed in the USPTO on May 27, 1993

21 21. The Opposer’s Glory Yau-Huai Tsai’s Mark “GLORY HOUSE” was registered as an  
22 U.S. Registration No. **1879695** on February 21, 1995 (**Opposer’s Registration**).

23 22. On Feb 13, 2001, a Section 8 was filed by the Opposer Glory Yau-Huai Tsai for the  
24 Opposer’s Registration (**1879695**). On May 11, 2001, the Declaration under Section 8 **was accepted**  
25 **and registered.**

26 23. On February 18, 2005 a Combined Declaration of Section 8 (10 year) and Section 9 was  
27 filed by the Opposer Glory Yau-Huai Tsai, and was accepted, registered and granted on April 02, 2005.

1           24.     On March 26, 2013 a Declaration of Incontestability under Section 15 for the Opposer's  
2 (Glory Yau-Huai Tsai's) Registration **1879695** was filed by the Opposer Glory Yau-Huai Tsai and was  
3 received by the USPTO.

4           25     On April 01, 2013 the Declaration of Incontestability under Section 15 for the  
5 Opposer's (Glory Yau-Huai Tsai's) Registration (Registration Number **1879695**) **was acknowledged**  
6 **and registered on April 01, 2013.**

7           26.     The Opposer Glory Yau-Huai Tsai has used the Opposer's Mark GLORY HOUSE in  
8 association with the Opposer's **goods and business services** in commerce **since July 1975 (Attached**  
9 **Exhibit – J )**, is a business license renewal letter sent by the "city of Monterey Park, California", in the  
10 year 1976).

11          27.     The Opposer Glory Yau-Huai Tsai's 'GLORY HOUSE' business and its services were  
12 established **in July of the year 1975**. At that time, Opposer's printing facilities were located in the  
13 City of Monterey Park, California.

14          28.     The Opposer's Filing Date (May 27, 1993) for the Opposer's Mark is almost **twenty**  
15 **years (20 years)** earlier than the Applicant's Filing Date (November 28, 2012).

16          29.     The Opposer's First Use Date (**September 16, 1975**) for the Opposer's Mark  
17 **precedes by almost twenty-five years (25 years)** the Applicant's Alleged First Use Date  
18 (01/01/2000) for the Applicant's Mark.

19  
20          30.     **Obviously, Perjury is willfully being committed by Applicants**

21                   Obviously, Applicant, BJK Glory House Catering Co., LLC and the owner Jo Ann Goin  
22 are willfully committing Perjury.

23          31     **Perjury committed by applicant Jo Ann Goin and**  
24 **Applicant BJK Glory House Catering Co., LLC.**

25                   Applicant Jo Ann Goin, in her **Declaration** (Serial Number 85789420), alleged under  
26 penalty of perjury that the mark "**GLORY HOUSE**" was first used by the applicant (BJK Glory  
27 House catering Co., LLC) or the applicant's related company or licensee, at least as early as

1 01/01/2000, and first used in commerce at least as early as 01/01/2000, and is now in use in such  
2 commerce.

3 Obviously, applicant Jo Ann Goin's statements are false statements. There was no  
4 Restaurant or Catering named "GLORY HOUSE" open on New Year's Day, January 01, 2000. Who  
5 are the applicant's related company or licensee?  
6

7 **32. Perjury intentionally committed by applicant Jo Ann Goin**  
8 **And Applicant BJK Glory House Catering Co., LLC.**  
9

10 Applicant, Jo Ann Goin in her **Declaration** (Serial Number 85789420) **further alleged**  
11 **under penalty of perjury that he/she believes that no other person, firm, corporation, or**  
12 **association has the right to use the mark "GLORY HOUSE" in commerce, either**  
13 **in the identical form thereof or in such near resemblance thereto as to be likely,** when used on or  
14 in connection with the goods/services of such other person, **to cause confusion, or to cause mistake,**  
15 **or to deceive;** and that all statements made of his/her own knowledge are true; and that all statements  
16 made on information and belief are believed to be true.

17 33. Obviously, Applicant, Jo Ann Goin and her associated group (applicant) "BJK Glory  
18 House catering Co. LLC" **are intentionally committing perjury.**  
19

20 34 **FACTS: Opposer Glory Yau-Huai Tsai's business service**  
21 **name "GLORY HOUSE" have been existing since 1975.**

22 **Opposer GLORY YAU-HUAI TSAI's trademark name "GLORY HOUSE",**  
23 **registration number 1879695, and the opposer's business services name "GLORY HOUSE" was**  
24 **established in July 1975, and has been registered in official records with the**  
25 **Patent and Trademark Office since 1993.**  
26  
27  
28



1           39       Defendants (applicant) BJK Glory House Catering Co., LLC and the alleged owner Jo  
2 Ann Goin of BJK Glory House Catering Co., LLC, have posted many photos in which applicant Jo  
3 Ann Goin, under “**Testimonials of Glory House Catering**” on their website, showing applicant Jo  
4 Ann Goin together with some other court judge (**Attached Exhibit - C**), and applicant Jo Ann Goin  
5 identifying herself as the trademark owner of GLORY HOUSE .

6           40       All those photos posted by Defendants (applicant) BJK Glory House Catering Co. LLC.  
7 and the owner Jo Ann Goin of BJK Glory House Catering Co., LLC **add false credibility** to the words  
8 which Jo Ann Goin posts on applicant’s website **leading people to believe that it is the 100% truth.**

9  
10          41       As a result, the Opposer’s (Mr. Glory Yau-Huai Tsai’s) business “GLORY HOUSE”  
11 and Opposer Mr. Glory Yau-Huai Tsai’s personal reputation are losing credibility.

12          42.       Many people think and believe that the “**Asian Guy**” **cannot possibly be the rightful**  
13 **owner of GLORY HOUSE.** Opposer’s (Glory Yau-Huai Tsai’s) business is continuously losing.  
14 During the past 5 years, **more than \$150,000.00 has been lost.**

15  
16          43       Defendants (applicants) Jo Ann Goin and BJK Glory House Catering Co., LLC are  
17 deliberately intending to deceive the consumer into believing that (applicant) Jo Ann Goin and  
18 (applicant) BJK Glory House Catering are the real owner of the Trademark GLORY HOUSE **which**  
19 **in fact belongs to Opposer Glory Yau-Huai Tsai,** by way of using untrue and deceiving  
20 webpages saying, “GLORY HOUSE is a trademark of Glory House Catering”

21          44       (Applicant) Jo Ann Goin and BJK Glory House Catering Co., LLC **are using their**  
22 **website containing false statements, such as “GLORY HOUSE is a trademark of Glory**  
23 **House Catering”, as false proof that they are the owner of the trademark “GLORY HOUSE”.**

24          45       The applicants (defendants) are identity thieves. Applicants are willfully committing  
25 trademark infringement against Opposer’s (Glory Yau-Huai Tsai’s) business trademark and business  
26 service trade name GLORY HOUSE, and are also stealing Opposer’s (Glory Yau-Huai Tsai’s)

1 personal and business reputations which Opposer (Glory Yau-Huai Tsai) has honestly built for almost  
2 forty (40) years.

3  
4 46 Additionally, someone, who Opposer Glory Yau-Huai Tsai believes, is from applicant  
5 Jo Ann Goin, BJK Glory House Catering Co., LLC (applicant) and their groups, is willfully committing  
6 fraud and falsely representing the trademark owner of GLORY HOUSE in order to make a totally  
7 incorrect story, communicating with Google's employees or Google's advertisement people, into  
8 deleting Opposer's (Glory Yau-Huai Tsai's) federally registered trademark name and business name  
9 GLORY HOUSE from Google's search engine. Instead, applicant Jo Ann Goin and BJK Glory House  
10 Catering Co., LLC (applicant) has become the trademark owner of GLORY HOUSE on Google's  
11 worldwide website.

12 47 Opposer, Mr. Glory Yau-Huai Tsai's GLORY HOUSE webpage (only 1-page long)  
13 was also suddenly taken down. It disappeared and was deleted without any notice from the hosting  
14 company -Godaddy.com because **the top of Mr. Glory Yau-Huai Tsai's GLORY HOUSE**  
15 **webpage had the words "GLORY HOUSE", and also stated that Glory Yau-Huai Tsai is the**  
16 **trademark owner.**

17  
18 48 In about 2011-2012, applicant Jo Ann Goin, the owner of "BJK glory House Catering  
19 Co. LLC" (applicant) used applicant Jo Ann Goin's position as a chairwoman of Irving Chamber of  
20 Commerce, TX, to access Opposer Mr. Glory Yau-Huai Tsai's **business GLORY HOUSE and** his  
21 personal information. Additionally, Jo Ann Goin (applicant) used her position as a chairwoman of  
22 Irving Chamber of Commerce, TX to lead people into believing that applicant Jo Ann Goin and her  
23 business BJK Glory House Catering, Co., LLC (applicant) are the real owners of the trademark  
24 (Registration Number 1879695) GLORY HOUSE. In another words, applicant Jo Ann Goin sat in the  
25 credible position of chairwoman of Irving Chamber of Commerce, TX **to verify to other people that**  
26 **her own personal business, "BJK Glory House Catering, Co., LLC" (applicant) is the true owner**  
27 **of Opposer's (Glory Yau-Huai Tsai's) trademark GLORY HOUSE. Applicant Jo Ann Goin**

1 and her BJK Glory House Catering, Co., LLC (applicant) **have intentionally committed perjury**  
2 **against Opposer's (Glory Yau-Huai Tsai's) trademark "GLORY HOUSE" and the personal**  
3 **identity of Opposer Mr. Glory Yau-Huai Tsai.**

4  
5 49 One year in the position of chairwoman of Irving Chamber of Commerce, TX **is**  
6 **enough time** to steal Opposer Mr. Glory Yau-Huai Tsai's business GLORY HOUSE and personal  
7 identity, and also **enough time** for Jo Ann Goin to spread deceiving story everywhere, not only within  
8 the United States but also to the rest of the world.

9 50 Additionally, applicant "Jo Ann Goin" used **her** position as a "chairwoman of chamber  
10 of commerce of Irving County", and her groups "BJK Glory House Catering Co."(applicant) to  
11 repeatedly spread the untrue story that applicant Jo Ann Goin owner of (applicant) BJK Glory House  
12 Catering Co., LLC. is **the real trademark owner of GLORY HOUSE, which in fact belongs to**  
13 **Opposer Glory Yau-Huai Tsai.**

14 51. Applicant Jo Ann Goin and applicant BJK Glory House Catering Co., LLC  
15 continuously **lie to the public** that they, "Jo Ann Goin and BJK Glory House Catering Co., LLC" are  
16 the real owners of the trademark "GLORY HOUSE".

17 52. As a result, the public is confused into believing that the gender of the owner of the  
18 registered trademark "GLORY HOUSE" is a female. Furthermore, Jo Ann Goin presents herself as the  
19 trademark owner of GLORY HOUSE on the applicant's website leading the people to further believing  
20 that the ownership of the trademark name "GLORY HOUSE" belongs to a lady, and "BJK Glory  
21 House Catering Co. LLC"

22 53 Obviously, the Public begins to think and believe that the trademark owner of "GLORY  
23 HOUSE" is a female.

24  
25 54 **Opposer Glory Y. Tsai (Full name: Glory Yau-Huai Tsai)** is a male, and when  
26 Opposer says that Opposer is the owner of trademark "GLORY HOUSE", almost no person believes  
27 this to be true. The people think that Opposer Glory Yau-Huai Tsai is not the real owner of

1 GLORY HOUSE as the Opposer says. **Many people believe that the person named “Glory Tsai”,**  
2 **“Glory Y. Tsai”, “Glory Yau-Huai Tsai” is a female.**

3 55 **Even the government, “United States Census Bureau” and “U.S. Department of**  
4 **Commerce”, sent one Asian person named “Jamie Lim” to come to Opposer’s address, ring the**  
5 **doorbell to verify who the man is, who the woman is, who the husband is, and who the wife is. In**  
6 **another words, the ‘United States Census Bureau” and the “U.S. Department of Commerce” was also**  
7 **seriously confused as to whether the person named “Glory Yau-Huai Tsai” is a male or**  
8 **female., and where this person lives?**

9 56 Opposer Glory Yau-Huai Tsai’s personal reputation, personal identity, and Opposer  
10 Glory Yau-Huai Tsai’s almost forty (40) year **ownership** of the business service name “GLORY  
11 HOUSE” was seriously damaged because of this ownership confusion. A lawsuit sooner or later will  
12 be filed against “Jo Ann Goin” and her group “BJK Glory House Catering, LLC.” (applicant).

13  
14 57. On December 19, 2012, Opposer GLORY YAU-HUAI TSAI, sent a certified mail  
15 (with a return receipt requested) (**Attached Exhibit - D**) to applicant “Jo Ann Goin” and applicant  
16 “BJK Glory House Catering Co., LLC” inquiring about details of applicant’s trademark. Said certified  
17 mail (7012 0470 0001 9453 4199) was received and signed by an employee of applicant “Jo Ann  
18 Goin” “BJK Glory House Catering Co., LLC” on December 26, 2012. (**Attached Exhibit – D**)

19 58 Opposer GLORY YAU-HUAI TSAI did not receive any response from applicant “Jo  
20 Ann Goin and BJK Glory House Co., LLC”. In other words, defendants, applicant “Jo Ann Goin and  
21 applicant BJK Glory House Co., LLC” did not care at all.

22 59. Opposer “Glory Yau-Huai Tsai”, the registered trademark owner of “GLORY HOUSE”,  
23 have personally made phone calls 2 or 3 times to (defendants’) applicant’s restaurant, but a lady from  
24 applicant’s (defendants’) restaurant, shortly after answering the phone, hangs up.

25 60. **In about June 2012**, Opposer (Plaintiff) Mr. Tsai believes that somebody, associated  
26 with Applicant’s (defendants’) associated groups falsely represented and identified that she/he is **the**  
27 **owner of “GLORY HOUSE”**, contacted GS1US, alleging that the business of “GLORY HOUSE” is



1 a Restaurant, and Food Production services, to request GS1US to assign an additional company prefix  
2 (8490460) to the business named "GLORY HOUSE". Now, they have used a business name spelled  
3 "GLORY HAUS", but both "GLORY HOUSE" and "GLORY HAUS" sound exactly the same.

4  
5 61 After Opposer contacted the GS1US by telephone, the GS1US corrected Opposer's  
6 business type back. (**Attached Exhibit - E**, an email letter sent by Glory Tsai to GS1US on June 14,  
7 2012).

8 62 However, many people had already been led to believe that Opposer's (Glory Yau-Huai  
9 Tsai's) business GLORY HOUSE is a restaurant/catering associated with and belongs to applicant  
10 "BJK Glory House Catering Co., LLC".

11 63 After that, even GS1US has also confusingly sent Opposer email newsletters  
12 related to restaurants, catering, or food products. Information related to book publishing,  
13 printing, printing machines, book shows, etc. --- have disappeared.

14 64 Obviously, applicant (defendants) Jo Ann Goin and applicant BJK Glory House  
15 Catering Co., LLC. are willfully using a kind of silently scandalous matters to cause confusion  
16 and mistake, and to deceive the people.

17 65 (Defendants) Applicant Jo Ann Goin and her (applicant) BJK Glory House  
18 Catering Co., LLC. had already planned to steal Opposer's trademark name "GLORY HOUSE"  
19 by paying \$325 to USPTO to get a service mark "GLORY HOUSE", thereafter changing their  
20 "BJK Glory House Catering Co., LLC." into the words, "GLORY HOUSE" only.

21 66 Not only this, but applicant can escape all liability that was created under the  
22 business name "BJK Glory House Catering Co. LLC."

23 67 In another words, this scandalous matter with intent of professional knowledge is  
24 an easy way for applicant Jo Ann Goin, applicant BJK Glory House Catering Co., LLC. and  
25 applicant's associated groups to get the exact the trademark name "GLORY HOUSE" without  
26 paying extra money to buy it.







1           89     Those people who made strange phone calls to me must send my personal  
2 information to those places where they say “the real owner of the trademark of GLORY  
3 HOUSE”, like applicant “BJK Glory House Catering”.

4           90.     The callers have those people who are infringing Opposer’s trademark “GLORY  
5 HOUSE” to make verification against Opposer, asking “whether this guy is an  
6 owner or worker in your GLORY HOUSE”

7           91     Opposer Glory Yau-Huai Tsai is the trademark owner of “GLORY HOUSE” but  
8 Opposer have been slandered and libeled by those identity thieves who infringe upon and steal  
9 Opposer’s personal identity to spread to world that the Opposer whose name, Glory Yau-Huai Tsai,  
10 Glory Y. Tsai or Glory Tsai is a female; and also infringe upon Opposer’s trademark name ‘GLORY  
11 HOUSE” saying that (applicants) are the owner of the trademark

12 Those identity thieves have become the owner, and Opposer Glory Yau-Huai Tsai has  
13 become a liar in the public eye.

14           92.     Opposer Glory Yau-Huai Tsai has been doing the business GLORY HOUSE for  
15 almost 40 years. OPPOSER GLORY YAU-HUAI TSAI is the registered trademark owner of

19           93.     Since applicant’s (defendants’) application mark name (Application number 85789420)  
20 is exactly the same as the trademark name GLORY HOUSE (Trademark Registration Number  
21 1879695) which belongs to Opposer (Plaintiff ) Glory Yau-Huai Tsai, both the same  
22 name mistakenly and confusingly create the same overall commercial impression.

23 Because applicant Jo Ann Goin and applicant BJK Glory House Catering Co., LLC is still  
24 continuously using their deceitful webpage stating that “GLORY HOUSE is a trademark of Glory  
25 House Catering Co. LLC” (Attached Exhibit-B).

26           94     Applicant Jo Ann Goin owner of applicant BJK Glory House Catering Co. LLC is still  
27 using their fraudulent evidence to deceive the public and intent to drive the public mouth to

1 **wipe opposer's (Glory Yau-Huai Tsai's) ownership of the trademark**

2 **GLORY HOUSE out of the public eye.**

3 95 Consumers and people worldwide, are confusingly led to believe that both marks  
4 belong to the same owner "Applicant - BJK Glory House Catering Co., LLC" **because** applicant "Jo  
5 Ann Goin and her associated BJK Glory House Catering Co..LLC (applicant)" are still posting those  
6 deceiving statements that "Glory House is a trademark of Glory House Catering Co., LLC"

7 **(Attached Exhibit-B)**

8  
9 96 Opposer Glory Yau-Huai Tsai, sole owner of federally registered trademark and  
10 business service name "GLORY HOUSE"; (federal trademark registration number 1879695) has been  
11 operating the business "GLORY HOUSE" since 1975. **(Attached Exhibit- J, a business license**  
12 **renewal letter in the year of 1976 sent by the "city of Monterey Park, California"; at that time our**  
13 **business GLORY HOUSE was located in the city of Monterey Park).**

14 97. Currently, the Opposer's (Glory Yau-Huai Tsai's) address: 1512 E. Maplegrove Street,  
15 West Covina, California 91792, which is already on record in USPTO, is the best contact address.

16 98 Opposer Glory Yau-Huai Tsai, sole owner of federally registered trademark and  
17 business service name "GLORY HOUSE"; has sustained serious damages not only financially, but  
18 also to Opposer's personal and business reputations, identities, credits, --.

19 99 **All of those are a result of trademark and trade name infringement and**  
20 **because of the registration filed by applicant Jo Ann Goin and applicant "BJK glory**  
21 **house catering company, LLC for the mark GLORY HOUSE shown in Application**  
22 **Serial No. 85789420.**

23  
24 100 **Opposer Glory Yau-Huai Tsai respectfully requests The Trademark Trial**  
25 **and Appeal Board that the registration of pending application Serial Number 85789420**  
26 **should be denied and canceled not only pursuant to Section 2(d) of the trademark Act but**  
27 **also to stop this highly fraudulent crime.**




